

Supervisory Board appoints Martin Drasch Chief Executive Officer of Manz AG

Reutlingen, September 28, 2018 – Manz AG, a global high-tech equipment manufacturer with a comprehensive technology portfolio, announces that Martin Drasch, Chief Operating Officer (COO) of the company since 2015, has been appointed as Chief Executive Officer by the Supervisory Board effective October 01, 2018.
